**CURRENT CONTEXT**

- Kerala HC (Aug 2025): Wetland Management Unit ordered.
- Reason: Pollution, encroachment, tourism threats.
- Linked to: Wetlands (Conservation and Management) Rules, 2017.
- Focus: Community, sustainable conservation.

**BACKGROUND**

- Kollam district, Kerala.
- Brackish-water, estuarine lake.
- 8 branches ("octopus shape").
- Name: 'Ashta' (eight) + 'mudi' (peaks), Malayalam.
- 2nd largest estuary in Kerala.
- Kollam: Ancient port, coir industry.

**PRELIMS FACTS**

- Ramsar Site: 2002.
- Inflow: Kallada River.
- Outflow: Neendakara estuary → Arabian Sea.
- Rich in: Mangroves, karimeen (pearl spot fish), birds.
- Kettuvallam: Traditional houseboats.
- Entry points to Kerala backwaters.



### 9. Pm national dialysis programme

The Government of India has significantly expanded the reach of the Pradhan Mantri National Dialysis Programme (PMNDP) and it is now operational across all 36 States and Union Territories, covering 751 districts.

**NEW HEALTH SCHEMES**

#### PRADHAN MANTRI NATIONAL DIALYSIS PROGRAMME

- Support is being provided to all States for provision of free dialysis services for poor, and subsidized services to all patients under NHM
- Under this, every facility will have 6 dialysis machines and will be extended up to 10 machines per facility
- Started in 219 districts across the country
- So far, 1,069 Dialysis Units, 2,319 Dialysis Machines have been made operational.
- 1,06,717 patients availed services
- 11,04,118 dialysis sessions held

## 11. Apna ghar initiative.

The Ministry of Petroleum and Natural Gas recently launched an ambitious initiative named 'Apna Ghar' aimed at improving truckers' long-haul journeys across the country.

### About Apna Ghar Initiative

- It is an initiative of the **Ministry of Petroleum and Natural Gas**, Government of India.
- It aims to provide comfortable and hygienic **resting spaces for truckers** across major highways in the country.
- As of July 1, 2025, a total of 368 'Apna Ghar' units with 4,611 beds have been **set up** by Public Sector Oil Marketing Companies (OMCs) at retail fuel outlets along national and state highways.
- The facilities at 'Apna Ghar' include:
  - Dormitories (10-30) beds
  - Restaurants/Dhabas
  - Self-cooking areas
  - Clean toilets
  - Dedicated **bathing areas** (Houdas)



### Geographic Features of sea of Japan


- Connected to the East China Sea via **Korea Strait**.




- Species: Asian Giant Tortoise (Manouria emys).
- IUCN Status: Critically Endangered.
- Habitat: Forested regions of Southeast Asia and Northeast India.
- Significance: Largest tortoise species in mainland Asia.
- It is the only tortoise that lays its eggs above ground in a nest, which the female constructs of leaf litter.
- They are native to South Asia found in Bangladesh, India, Indonesia, Malaysia, Myanmar, Thailand and Singapore (Extinct).



## 11. Leap-1 Mission.

A budding space tech startup Dhruva Space from India, is set to launch its first commercial satellite mission called LEAP-1.

- It is developed by Dhruva Space and Australia-based Akula Tech and Esper Satellites.

  - **Nexus-01**: It features an advanced artificial intelligence (AI) module.
  - AI module promises unprecedented **on-orbit intelligence** with onboard data processing and AI/ML model re-training capabilities for rapid, near-real-time insights.
  - AI flexibly supports applications such as **fire detection and spectral analysis**, continuously improving via live sensor data retraining.
  - **Esper Satellites' OTR-2 mission**: It is equipped with a cutting-edge hyperspectral imager.

#### Nilgiri Tahrs recent joint census

A joint census in Kerala and Tamil Nadu has reported a population of 2,668 Nilgiri tahrs. According to Forest department officials, 1,365 tahrs belong to Kerala and 1,303 to Tamil Nadu. The Eravikulam National Park (ENP) is home to the largest contiguous population of Nilgiri tahr in Kerala, numbering 841.

**biochar's potential**



India generates over 600 million metric tonnes of agricultural residue and over 60 million tonnes of municipal solid waste every year. A significant portion of both is burnt openly or dumped in landfills, leading to air pollution from particulate matter and greenhouse gases such as methane, nitrous oxide, and CO<sub>2</sub>.

- Since then, the ethanol blending in India has come a long way, achieving a 10% ethanol blend target in 2021-22, which was further increased to 12.06% in 2022-23, 14.06% in 2023-24, and 20% in July 2025, which was initially set to be achieved by 2030.
